TEST RESULTS

STAINING RESISTANCE; EKOTEKS 49(*)

Samples are processed to be approximately 30cm x 40cm in size for each stain.

After the stain is applied, it is kept on the sample for approximately 15 minutes, the solution is prepared in warm water with an American standard mop, then it is wiped with a clean microfiber cloth.

The method chosen and the degree of staining after cleaning are done using ISO 105 A03, standard gray scales
